Making WLTP as simple as 3,2,1

The countdown is on. In a year of unprecedented change, there is one more change for Leasing Service Providers (LSPs) to manage: seamlessly integrating the Worldwide Harmonised Light Vehicle Test Procedure (WLTP) calculations seamlessly into your workflows by 1st January 2021.

But help is at hand. JATO has been applying its world-class data collection and management expertise to develop our new WLTP service. Our ambition is to help you make WLTP just part of business as usual. Starting with giving you the facts.

- FACT 1** **WLTP is a new testing procedure** to determine the levels of pollutants, CO₂ emissions, fuel economy, electricity consumption and electric range values for traditional, hybrid and electric vehicles. It's a more accurate test as it is based on realistic driving conditions and takes account of the optional equipment.
- FACT 2** **The purpose of WLTP is to help leasing customers make more environmentally friendly fleet decisions.** To help drive towards a net zero future for Europe, the EU has set emissions targets which companies will need their fleets to meet. The current target is 95g of CO₂ per kilometre. This will reduce by 15% in 2025, and 37.5% in 2030.
- FACT 3** **WLTP poses an unprecedented challenge to your business:** you will now need emissions data for every car you offer for leasing.
- FACT 4** **By 1st January 2021, it'll be mandatory for all LSPs in most member states to use WLTP data in 2 areas:**
1. **Quotations:** You'll need to advise your customers of the CO₂ emissions and fuel consumption of each vehicle on offer: and
 2. **Taxation:** You'll need to advise them on their tax liability which, in most markets, will be based on or influenced by the vehicles **WLTP** values (the higher the emissions, the higher the tax)
- FACT 5** **There are 3 barriers for LSP in complying with WLTP:**
1. There is no centralised **WLTP** database.
 2. To get the LSP values of the vehicles you offer, you'll need the ability to call **WLTP** calculators across multiple manufacturers.
 3. To do this, you'll need the scalable network bandwidth, data, technology, infrastructure and team to access, process and integrate **WLTP** values into your workflows.

FACT 6 JATO's WLTP Service provides a **comprehensive and secure data service** that will enable your team to obtain accurate **WLTP** calculations for each individually configured vehicle you offer – including standard and optional equipment.
